Work Permit:

Permit to legally work full-time, part-time, freelance, or start your own business.



Resident Visa:

Long-term visa which allows cardholders to stay in Taiwan for 1-3 years.



Alien Residence Certificate

The legal status of foreigners residing in Taiwan for an extended period.



Re-entry Permit

Allows unlimited entry and exit from Taiwan (even during the COVID-19 period).

Meeting ANY ONE of the following criteria.



Working Seniority

Over 8 years of professional experience in the digital economy sector.



Academic Achievement

Graduated from a university ranked in the **Top 500 worldwide** and holding a doctoral degree from that institution.



Salary

Employed in a relevant field with a recent monthly salary of at least NT\$160,000.



Relevant Expertise

Included Ph.D. degree and winning awards, or having more than 4 years of relevant work experience.
